#### 6. General Business/New Business:

- a. Review of April Tournament Milwell Road Community Centre venue lacks extra space, Kuluin School hall has been booked for June tournament. Look at getting second person for First Aid. Mats are currently quite slippery and pull apart quite easily. MP advises making the tournament mats a 10x10 ring, up from 8x8. Plan to move current mats to use in the junior divisions and purchase new thicker mats for adult competition. Will assess feasibility in future budget.
- b. Review of Easter Picnic & Training Day Nothing to add, reimbursement submitted to VD.
- c. Replace association BBQ Purchase possibly in new financial year. Dispose of old BBQ by MP.
- d. QLD camp Booked for 60 attendees, 51 required to pay by association. At the time 40 have paid, 48 have shown interest. Some dojo equipment to be taken to camp (mats, weapons and kumite gear).
- e. June tournament preparation Entry forms to be distributed next week. Adam Sensei has proposed an idea to distribute a questionnaire to all members to learn why tournament participation is low. Questionnaire will be put out in the following week.
- f. Soke Cup competitor kumite gear It has been proposed by Sensei Sandra that Soke Cup competitors that do not have their own head gear should take one head gear from the dojo after the June tournament. This will help the competitors get comfortable with their preferred head gear.
- g. Entry fees for Soke Cup Event entry fees will be covered by the association, each adult event is 4000 yen, junior events are 3000 yen. Total for entry fees will be approximately \$150-\$200 per competitor. MP will have final cost after submitting entries.
