President's Report

Acting Treasurer's Report - 3rd March 2023

1) Budget (see spreadsheet)- Moneys collected since the last committee meeting included 1 month of membership fees for a total of \$424.30 and \$220 from the February 100 Club fundraiser. The total to be allocated was \$644.10.

As per allocation rules, 1 month @ \$340/mth was allocated to Soke's 2023 visit bringing the current balance to \$4059.81. An amount will be deduced from this total when we receive the invoice from Sensei Noonan for our share of the international airfares for Soke's last visit.

1 month @ \$50/month was allocated towards the replacement of the mats bringing the balance to \$2371.88.

\$254.10 was allocated to this year's Soke Cup which included \$220 from the sale of tickets in the 100 club fundraiser for February and the remaining \$34.10 left over from all other allocations. The balance is currently at \$3854.35.

This brings us to a balance in the bank of \$12,914.85 (with \$95 yet to be banked from the 100 club cash sales).

- 2) \$300 is budgeted for the Easter picnic.
- 3) I have applied with Grill'd Sunshine Plaza for a spot in their Local Matters fundraising platform. For those who don't know the program, each month 3 jars are placed at the front of the restaurant each representing a local club, association, or special cause. Customers are given tokens upon purchase of food which they choose to put in one or more jars. At the end of the month, the jar containing the most tokens earns \$300 for its club/association and the other two earn \$100. So, no loser in this one and every little bit helps, I guess. I am expecting to hear back in the next few days on the outcome of the application. Last time we participated, we had a jar in the following month's fundraiser. I will keep the committee updated on the progress of the application so we can get an early start on promoting the campaign as soon as I hear back.
